1. What motivated you to seek nomination for this committee?

I have been involved in various ministries at St Davids over the past decade and currently serve as Rector's Warden. I have had several discussions with our clergy regarding the future of my ministry and the Church Foundation was identified as the right place for me to use my gifts. My time on our Vestry ends in May, 2010 so this opportunity is well timed and is of great interest to me.
