

Application for Financial Assistance for Congregations & Programs through the 2020 Budget

Does your congregation have a program or ministry that could use financial support from our Diocese? Have you wanted to start a new ministry or continue an old one, but just do not have the finances to do so? If so, then this grant application may be right for you. (Please note: These grants are only for those within the Diocese.)

As part of its annual Budget, the Diocese allocates funds for programs and ministries at the congregational level. This grant process is open to all congregations. You do not need to be a previous recipient to be eligible. However, being a previous recipient does not guarantee that your grant will be renewed.

If you would like to have your program/ministry considered for funding, all of the following items will need to be included in your application packet.

- * Completed Application Information sheet - download [here](#)
- * 2018 Parochial Report - as filed with Church House
- * 2017 Audit - as filed with Church House
- * 2018 Actual Year End Financials - include the actual end-of-year numbers
- * 2020 Budget - include the actual year-to-date numbers
- * Description of the program/ministry to be funded
- * If you received funding in 2018, or are approved to receive funding in 2019, please describe both how the money was/will be used and whether or not you were able to achieve your goals for the ministry or program.
- * The amounts of funding for approved applications will be allocated from projected available

funds. Incomplete applications will not be considered.

Completed application packages must be submitted electronically, and must be received no later than Friday, April 15, 2019. Submit the package to Douglas Horner at dhorne@diopa.org.

6. Of the funds being requested, how much of it (if any) will be used for salary to support the program/ministry?
7. Of the funds being requested, how much will be for clergy salary and how much for lay salary?
8. Did your congregation receive financial assistance in 2018 and/or 2019? If so, what was the amount and what was it used for?
9. What will happen if your funding request is denied? Have you attempted to fund the program/ministry by alternate means; e.g., fund raising, private grants, etc.?
10. Will you receive any financial support from other sources in 2019? If yes, please list the source and the amount. Do you anticipate receiving the same level of support from these entities in 2020?
